9	(a) Concurrent Receipt in Connection With
10	CSRC.—Section 1413a(b)(3)(B) of title 10, United States
11	Code, is amended by striking "creditable service," and all
12	that follows and inserting the following: "creditable serv-

14	"(i) the retired pay of the retiree is
15	not subject to reduction under sections
16	5304 and 5305 of title 38; and
17	"(ii) no monthly amount shall be paid
18	the retiree under subsection (a).".
19	(b) Concurrent Receipt Generally.—Section
20	1414(b)(2) of title 10, United States Code, is amended
21	by striking "Subsection (a)" and all that follows and in-
22	serting the following: "Subsection (a)—
23	"(A) applies to a member described in
24	paragraph (1) of that subsection who is retired
25	under chapter 61 of this title with less than 20
26	years of service otherwise creditable under

chapter 1405 of this title, or with less than 20
years of service computed under section 12732
of this title, at the time of the member's retire-
ment if the member has a combat-related dis-
ability (as that term is defined in section
1413a(e) of this title), except that in the appli-
cation of subsection (a) to such a member, any
reference in that subsection to a qualifying
service-connected disability shall be deemed to
be a reference to that combat-related disability;

tired if the member does not have a combat-re-
lated disability.".
